Show Ring Outfitters Consignment Agreement

This is a Consignment Agreement, whereby _____ (herein referred to as the "Consignor") is entering into an agreement on this date, _____, with Show Ring Outfitters to sell the riding apparel and/or accessories (herein referred to as "Items") described in Inventory A and owned by the Consignor. Items will be sold by Show Ring Outfitters according to the terms below:

- **Acceptable items:** All Items must be clean (dry-cleaned), in good repair, and of the current style. Show Ring Outfitters reserves the right to refuse items that do not meet our criteria for style, condition, or for any other reason.
- **Shipping:** All items shipped to Show Ring Outfitters must be sent insured and postage paid.
- **Consignment Period:** The consignment term shall be for twelve (12) months, starting on the date shown above. Consignor may ask for unsold Items to be returned at any time, however, Consignor is responsible for all shipping and insurance costs incurred in returning the Items to the Consignor. If any of the Items have not sold at the expiration of the initial consignment term, Show Ring Outfitters will contact the Consignor, via the phone number and/or e-mail address provided by the Consignor in this Agreement, to discuss price adjustments or the return of the Items to the Consignor. If the Consignor chooses to have the Items returned, Consignor is responsible for all shipping and insurance costs to do so. In the event Show Ring Outfitters is unable to reach the Consignor as described above within 45 days of the consignment period expiration, the Items shall automatically become the sole property of Show Ring Outfitters and shall be donated and/or sold in any manner that Show Ring Outfitters sees fit, with the Consignor receiving no proceeds from the sale.
- **Price:** Show Ring Outfitters will set the price of the Items. At the Consignor's request, and by mutual agreement, Show Ring Outfitters and the Consignor may set minimum proceeds (amount to be paid to Consignor) for any or all of the Items.
- **Commission:** Consignor understands and agrees that Show Ring Outfitters will be entitled to 25% to 40% of the final sales price (excluding tax) of each Item sold as compensation for Show Ring Outfitter's efforts in selling the Item. See below for commission rate, based on type/age of item. Consignor's share is not to exceed 75% to 60% of the final sales price (excluding tax) of each Item.
 - 25% -- suits, day coats or western sets with a list price over \$1,000 (less than 10 years old)
 - 30% -- all other non-clearance items
 - 40% -- all clearance items (generally suits and day coats listed for under \$500, shirts and vests listed for under \$85, derbies listed for under \$75. Questions? Please call.)
- **Payment:** Each month, Show Ring Outfitters issues checks for Consignors whose Items sold during the previous month. Checks will be made out to the Consignor listed on this Agreement, and mailed to the address listed below.
- **Liability:** Show Ring Outfitters makes every effort to maintain all Items in clean, safe condition. However, Show Ring Outfitters is not responsible for damage or loss of Items due to theft, fire, flood, or any other reasons beyond Show Ring Outfitters' control during the duration of this Agreement.

This Consignment Agreement constitutes the entire agreement between the parties. To the extent any clause within the agreement is deemed unenforceable, the remainder of the agreement shall remain intact and enforceable to the extent permitted by law. Failure to enforce any term of this contract does not result in a waiver of that term. This Agreement will be governed and interpreted according to the laws of the State of Wisconsin.
